

- Performing sexual acts on the body
- Stealing personal property from the body of the deceased
- Failing to embalm, bury, or cremate as contracted
- Replacing the casket provided without consent
- Burying the wrong body
- Using the wrong gravesite
- Unlicensed Funeral Home Staff handling the deceased

#### Who May Sue For Funeral Home Negligence?

In the troubling circumstance where a deceased loved one has been the victim of funeral home negligence, family members may have the right to sue for compensation.

This May Include:

- Surviving Children
- Surviving Spouses
- Surviving Parents
- In some cases, extended family or another party who is affected by the funeral home's negligence.
